Governor Bullock has issued a "Shelter in Place" mandate that went into effect at 12:01 March 28th, 2020. The Town of Eureka will comply to this order and is asking all citizens in our community to shelter at home. Essential services as outlined within the Governor's Directive is on our website (<u>www.eurek-mt.gov</u>). <u>Stay home</u> unless you are working an essential job, providing a service for someone in need, getting essential supplies and groceries including medical prescriptions, or attending to yours or your family medical needs. Any gathers of more than 10 people are prohibited regardless of place/location.

We know that this is a challenging time, and we ask all of our citizens to help us by responding to this Executive Order and stay home. If you do need to go somewhere please practice social/physical distancing and stay no less than 6 feet apart. Wash upon returning to your home and for precaution, wash/disinfect any item that you had with you or that you purchased prior to bringing into you home.

The Eureka Town Hall will be closed through April 10th, 2020 as directed to the public. Our Police, Public Works, and Clerks remain at their positions and will continue to provide services throughout this time period.
